CYCSPRWG and SCCDSAC Update

The Children, Youth and Community Services Policy and Research Working Group (CYCSPRWG) meeting was held in Melbourne on 25 September 2013. As AJJA are a standing item on the agenda, Dr Mark Collis presented the agenda item in person. Dr Collis updated members on the progress of the National Youth Justice Framework and the outcome of the Australasian Youth Justice Conference. He also presented the AJJA Annual Report and AJJA work plan 2013-14 for members noting and endorsement.

The Standing Council on Community and Disability Services Advisory Council (SCCDSAC) approved AJJA budget bid in relation to 'Linked data collection project' and 'Data collection to measure juvenile Recidivism Stage 2-measuring severity' out of session. AJJA are commissioning the AIHW to undertake these projects and have provided SCCDSAC with a document outlining the anticipated timeline, milestones and payment schedule.

Trauma Informed Practice Guide

The working group for the research project 'Trauma informed practice' has been meeting regularly and has developed a proposal which was endorsed by AJJA members at the recent teleconference. This project will now see Victoria take the lead in guiding peer review of literature research in the area and commencing the development of the project. At the November AJJA meeting a Project Control Group (PCG) will be formed of select AJJA members and progress relating to this will be confirmed.

PYJA Update

The National Youth Justice Framework is still being reviewed. AJJA members have agreed for it to become a Principles based document, consequently changing the title to 'Principles of Youth Justice in Australia'. A designer has been employed and created a draft document which was distributed to members recently, and presented to CYCSPRWG. Currently Members are required to seek consultation in their jurisdictions and prepare to deliver feedback at the November AJJA meeting.

Jurisdiction in Focus

Integrated Statutory Service - Australian Capital Territory

A key action in the Community Services Directorate (CSD) Business Plan 2013-14 is the creation of a single statutory service.

The integration process will be assisted by the implementation of the Integrated Management System (IMS) where we will have a single information management system that uses the same processes, tools and language across CPS and Youth Justice Case Management (YJCM).

The integration of services is being driven by research and evidence that young people who come into contact with the youth justice system have been overwhelmingly the product of abuse and neglect. There is significant evidence, from literature, that a child and young person centred, well timed and effective response early in a young person's life can reduce the chance of offending.

CPS and YJCM will be the primary branches affected by the changes but there will also be implications for other business units within CSD. It is expected that the service will be fully operational in 2014-2015.

Youth Justice Reforms - Tasmania

The Tasmanian Government is currently embarking on a series of significant reforms that will impact on the Youth Justice System, some of these include:

- The Continuum of Care to Prevent Youth Offending and Re-Offending:
 - This project aims to apply a public health approach to crime prevention, this project will provide Government with recommendations that will assist in the development of short, medium and long term strategies, which will strengthen the Primary, Secondary and Tertiary intervention options that exist across the Continuum.
- The Youth Justice Act (Miscellaneous Amendment) Bill 2012.
- Search Practices in Tasmania for Young People in Custody in Custodial Premises.
- Following a successful trial, the continuation of the Specialised Youth Justice Court (SYJC) in Southern Tas and the adoption of this SYJC in Northern Tas commencing 2014.
