Role: A youth justice decision-making collective whose purpose is to share information of relevance for all youth justice jurisdictions, support the collection of relevant youth justice data, support and contribute to research in the area of youth justice and promote and maintain national principles, standards and guidelines for youth justice.

PARTNERS

To build the national evidence base for youth justice policy AYJA works in partnership with Commonwealth entities the Australian Institute of Health and Welfare (AIHW) and the Productivity Commission (PC).

Each year AYJA commissions a suite of publications through an enduring MoU with AHIW and contributes to Chapter 17 of the RoGS.

The YJ DIG provides technical expertise for youth justice to both AIHW and the PC.

AUSTRALIAN INSTITUTE OF HEALTH AND WELFARE (AIHW)

AIHW manages the Youth Justice National Minimum Data Set (YJ NMDS) for AYJA and works closely with the YJ DIG to deliver a program of data and reporting for youth justice in Australia.

AIHW manage the YJ DIG meetings that comprise of jurisdictional representatives of statutory youth justice agencies from each Australian state and territory, AIHW, PC and ABS.

PRODUCTIVITY COMMISSION (PC)
